New Appointees (Paid and Non-Paid), Contractors, Volunteers, and CWTs


All New Appointees (Paid and Non-Paid), Contractors, Volunteers, and Compensated Work Therapy (CWT) workers are required to complete VA Information Security Awareness FY09 and VHA Privacy Policy Text Training FY09 in order to obtain a VA-issued ID badge and/or computer/phone access codes. VA Information Security Awareness FY09 and VHA Privacy Policy Text Training FY09 can be completed via the Employee Education System (EES) website. 

Click on "First Time User."




Check the category of VA user you will be (Paid VA employee or VA Other).




Enter your full (legal) first name, middle name, and last name.

Click on the "Submit" button.




From the drop-down menu, select one entry. Then click on the "Submit" button.

Click on the "Submit" button.




Create a special username that you will use.

Create a special password – one that you are <u>not</u> already using on any VA networked computer.


Type your new password in again.

Click on the "Submit" button.




Follow the instructions.

Enter the User Name and Password that you just created.


Click the "Login" button.


On the Left side, Click: Available Courses




This will open the Advanced Search.

Click: Search




On the Results Screen, find the course, "VHA Privacy Policy Text Training – FY09." Find and Click the Sign Me Up link.

You now need to search for the Information Security Awareness course.


Find and Click: Available Courses




This will again open the Advanced Search.

- 2) VHA Privacy Policy Text Training FY09.


Click on the course title to begin taking each course.
